SPEEDING IN SCHOOL ZONE	\$354.00

- * Charges may be dismissed if defendant remedies this defect, including payment of all late registration fees, within 10 working days. A fee of \$10.00 must accompany proof. Applies to expired inspection if certificate had not been expired for more than 60 days.
- ** Charges shall be dismissed upon verification of evidence that insurance was in effect on the vehicle driven on the date of violation.
